The undersigned in order to form a Corporation under the provisions of Title 30, Chapter 1, Idaho Code submits the following articles of incorporation to the Secretary of State.

1. Name. The name of the corporation is Idaho Dentists' Insurance Agency, Inc.
2. Authorized shares. The aggregate number of shares the corporation is authorized to issue shall be 1,000 all of which shall be common voting stock.
3. Registered office and agent. The registered office of the corporation is located at 1220 West Hays Street, Boise, Idaho 83702. The corporation's registered agent is Dr. R. Quinn Duferrena, DDS and the address of the registered agent is 1220 West Hays Street, Boise, Idaho 83702.
4. Incorporator. The name of the incorporator is Michael R. Jones and the incorporator's address is 508 N. 13th Street, Boise, Idaho 83702.
5. Corporate purpose. The purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
6. Board of Directors. All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of, its board of directors, subject to any limitation set forth in a shareholder agreement authorized under section 30-1-732, Idaho Code. The number of directors constituting the initial board of directors shall be nine (9). The number of directors of the corporation shall be fixed from time to time by or in the manner provided in the bylaws, but the number thereof shall never be fewer than nine (9).
7. Indemnification. The corporation shall indemnify the directors and officers of the corporation to the fullest extent permitted by the Idaho Business Corporation Act, as the same exists or may hereafter be amended (but, in the case of any such amendment, only to the extent that such amendment permits the corporation to provide broader indemnification rights than the Idaho Business Corporation Act permitted the corporation to provide prior to such amendment).
