



ARTICLES OF INCORPORATION

I

The name of this Corporation shall be the Sun Bird Environmental Center Incorporated.

II

The purposes for which Corporation is formed are:

- a) The promotion of environmental and outdoor education for youth, ages 9 to 16 years of age. Financial support for this organization will be by tuition from each participant and contributions.
- b) The general purposes and powers conferred on non-profit corporations under the laws of the State of California, including the power to contract, rent, buy or sell personal or real property, provided however, that this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this Corporation.
- c) No substantial part of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate or intervene in any political campaign

(including the publishing or distribution of statements) on behalf of any candidate for public office.

This Corporation is organized pursuant to the General Non-profit Corporation Law of the State of California. This Corporation does not contemplate pecuniary gain or profit to the members thereof and it is organized for non-profit purposes.

The principal office for the transaction of the business of this Corporation is located in the County of Alameda, State of California.

The authorized number and qualifications of members of the Corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members and their liability, shall be set forth in the By-laws.

VII

The property of this Corporation is irrevocably dedicated to environment and outdoor education and no part of the income or assets of this Corporation shall ever inure to the benefit of any officer on the Board of Directors. Upon the dissolution or winding up of this Corporation, its assets remaining after payments, or provision for payment, of all debts and liabilities of this Corporation shall be distributed to a non-profit fund, foundation or Corporation which is organized and operated exclusively for charitable purposes and which

has established its tax exempt status under Section 501(c) (3) of the Internal Revenue Code.

If this Corporation holds any assets in trust, or the Corporation is formed for charitable purposes, such assets shall be disposed or in such manner as may be directed by the Superior Court of the County in which the Corporation has its principal office, upon petition therefore by the Attorney General or by any person concerned in the liquidation, in proceeding to which the Attorney General is a party.


