Pursuant to the provisions of Section 30-1~~1~~61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is IDAHO MARKETSPACE INNOVATORS, INC.

SECOND: The following amendment to the Articles of Incorporation was adopted by the sole shareholder of the Corporation on the 1st day of February, 1996, in the manner prescribed by the Idaho Business Corporation Act:

Article I is hereby amended to read as follows:

THIRD: The number of shares of the Corporation outstanding at the time of such adoption was 1,000,000 and the number of shares entitled to vote thereon was 1,000,000.

FOURTH: The number of shares voted for such amendment was 1,000,000 and the number of shares voted against such amendment was ZERO (0).

In all other respects, the Articles of Incorporation filed April 12, 1995, shall remain in full force and effect.


