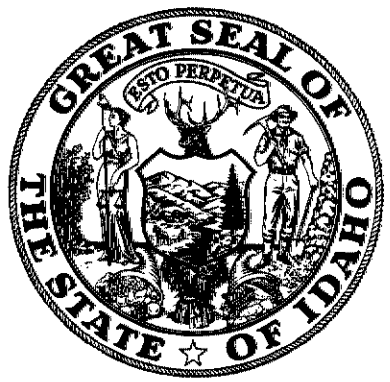

ARTICLES OF INCORPORATION

OF SEP 12 11 36 AM '89

We, the undersigned, being all adult citizens of the United States of America, do hereby associate ourselves for the purpose of forming a corporation pursuant to Chapter 1 of Title 30, Idaho Code, and we do hereby adopt and certify the following Articles of Incorporation, to-wit:

ARTICLE I

The name of this corporation shall be "Raneco Company."

ARTICLE II

The term of existence of this corporation shall be perpetual.

ARTICLE III

The purposes for which this corporation is organized are the transactions of any and all lawful businesses for which corporations may be incorporated under this act.

ARTICLE IV

The aggregate number of shares which the corporation shall have the authority to issue is Five Hundred (500); the shares shall consist of one (1) class only; the par value of each share shall be the sum of Ten Dollars (\$10.00); the total authorized capital stock of the corporation is the sum of Five Thousand Dollars (\$5,000.00). The stock of this corporation shall be nonassessible.

ARTICLE V

The address of the initial registered office of the corporation is 125 Johnson Avenue, Orofino, Idaho 83544. The name of the initial registered agent of the corporation at the initial registered office of the corporation is Shirley P. Cochrane. The mailing address of the office of the corporation is Post Office Box 2624, Orofino, Idaho 83544.

The initial Board of Directors shall consist of two (2) directors. The names and addresses of the persons who are to serve as the directors until the first annual meeting of the shareholders and until their successors be elected and qualified are:




