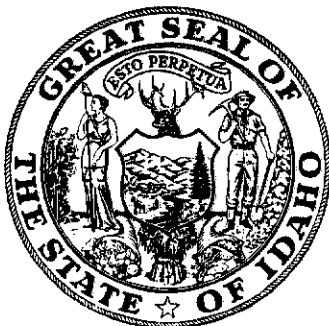

FIRST: The name of the corporation is M & M Cafe, Inc.




