ARTICLES OF INCORPORATION

OF

CREST CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full age, and citizens of the United States of America, in order to form a corporation for the purposes set forth below under the laws of the State of Idaho, do certify as follows:

I.

That the name of the corporation shall be CREST CORPORATION.

II.

The purposes for which said corporation is formed are:

(a) To own and operate hotels, motels, inns, cafes, restaurants, bars and cocktail lounges, and to do all things necessary for or convenient thereunto.

(b) To buy, sell and generally engage in the wholesaling and retailing of general merchandise and personal property.

(c) To buy, sell, deal in, hold, improve, subdivide, and lease real property; to mortgage, lease and encumber the same; to build, maintain, and operate buildings and structures, and to do all things necessary for or convenient thereunto.

(d) To acquire, buy, sell, mortgage, lease, encumber or otherwise dispose of such real and personal property as the corporation may desire and the incidents thereto convenient to the conduct of such a general business corporation and to do all other things necessary or convenient for the purpose of carrying out this subsection.

(e) Acquire and hold shares, stocks, debentures, bonds, obligations, securities and other instruments issued or granted by any company carrying on business in the United States or any of its territories or in any foreign country or granted by any government or

public body; to deal and trade in investments and securities in any company or corporation and in this corporation.

(f) To buy, sell, operate, manage, lease or otherwise conduct and promote businesses and enterprises, and to render all other or desirable services in connection therewith.

(g) To carry on any business which the corporation may deem proper or convenient whether connected with any of the foregoing purposes or otherwise, or which may be calculated to promote the interests of the corporation or to enhance the value of its properties or businesses.

(h) To have and to exercise all the powers conferred by the laws of the State of Idaho upon corporations formed under the acts and pursuant to and under which this corporation is organized.

III.

The corporation is to have a perpetual existence.

IV.

The location and post office address of the registered office of the corporation is Trail Motel, Soda Springs, Caribou County, Idaho.

V.

The total authorized number of shares of capital stock is 250 shares of the par value of \$100.00 per share, and an aggregate par value of \$25,000.00, all of which authorized capital stock shall be common stock, fully paid and non-assessable.
