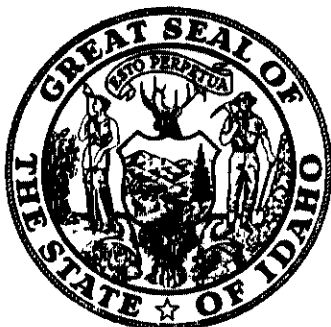
CERTIFICATE OF AMENDMENT OF

The current name of the Corporation is ACE MACHINERY AND IMPLEMENTS, INC., and it is a corporation existing under the laws of the State of Idaho.

2. The amendment(s) adopted are to change ARTICLE IV to read as follows:
The classes and aggregate number of shares of capital stock which the Corporation shall have authority to issue are 1,000 shares of voting common stock and 9,000 shares of non-voting common stock all at no par value.

3. The amendment(s) adopted are to change ARTICLE V to read as follows:
The shareholders of the Corporation shall have preemptive and preferential rights of subscription to any shares of stock of the Corporation within their respective class, whether now or hereafter authorized, or to any securities convertible into such shares or carry a right to subscribe or acquire such shares.

4. The amendment(s) were adopted by the Board of Directors on the 13th day of DECEMBER, 1993.

5. The Corporation has not issued any shares and therefore no shareholders are entitled to vote.

6. All of the directors voted for such amendment.


