ARTICLES OF INCORPORATION

OF

BROKMELING BROS., STEEL CORP.

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE ONE: Name - The name of the corporation is Broemeling Bros., Steel Corp.

ARTICLE TWO: Duration - The period of duration of the corporation shall be perpetual.

ARTICLE THREE: Purposes - The purpose of the corporation is steel products manufacture and sale and any and all businesses for which corporations may be organized under the Idaho Business Corporation Act.

<u>ARTICLE FOUR</u>: Powers - This corporation shall have all of the powers conferred by the Idaho Business Corporation Act.

ARTICLE FIVE: The aggregate number of shares that the corporation shall have the authority to issue is 50,000.00 shares, with a par value of \$1.00 each, which is an aggregate par value of \$50,000.00. Such shares shall all be of one class, to be known as common stock, and all shares shall be non-assessable.

ARTICLE SIX: Preemptive Rights - The preemptive rights of shareholders to acquire additional shares of the corporation shall be as provided under the Idaho Business Corporation Act.
