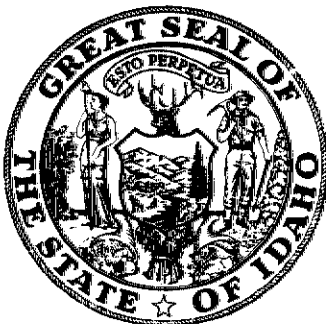

The undersigned, acting as sole incorporator of a corporation under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:
