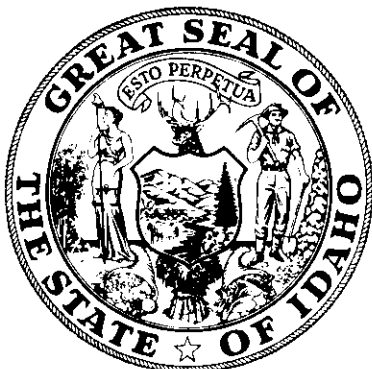

3. The name which it shall use hereafter in the State of Idaho is Fluor Constructors International, Inc.





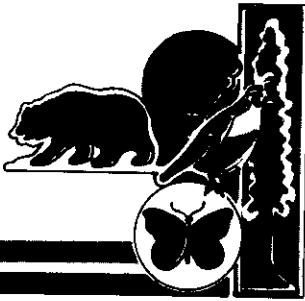
