

CERTIFICATE OF AMENDMENT 85 APR 5 PM 4 54

TO

CERTIFICATE OF LIMITED PARTNERSHIP

OF

WLP FOUR LIMITED PARTNERSHIP

1. The name of the limited partnership is WLP Four Limited Partnership.

2. This Certificate shall be filed April 5, 1985.

3. The first paragraph of Paragraph 6 of the Certificate of Limited Partnership of the limited partnership, filed March 19, 1985, hereby is amended to read as follows:

The partners have agreed to make monthly cash contributions to the limited partnership at the following times and in the following amounts:

April 15, 1985	through December 15, 1985	\$567.89
January 15, 1986	through December 15, 1986	399.75
January 15, 1987	through December 15, 1987	366.33
January 15, 1988	through December 15, 1988	158.17

4. The third paragraph of Paragraph 6 of the Certificate of Limited Partnership of the limited partnership, filed March 19, 1985, hereby is amended to read as follows:

The partners have agreed to make additional cash contributions to the limited partnership, in excess of those set out in the first paragraph of this Paragraph 6 in a total amount not to exceed \$12,760, at the call of the general partner from time to time, to meet additional obligations and expenses of the limited partnership during the initial seven (7) years of its existence. The general partner shall give the partners not less than twenty (20) calendar days' written notice for the payment of the designated amount of such additional periodic cash contribution. Such contributions shall be made by the general and limited partners in the same proportions as their monthly capital contributions, as set out in the second paragraph of this Paragraph 6.

5. The amendments set out in this Certificate are made as a result of the First Amendment to Limited Partnership Agreement dated April 5, 1985 among all the partners.

6. Except as amended herein, the information set out in the Certificate of Limited Partnership of the limited partnership, filed March 19, 1985, remains current and accurate.

IN WITNESS WHEREOF, on its own behalf and pursuant to the limited power of attorney vested in the undersigned to execute this Certificate of Amendment to Certificate of Limited Partnership of WLP Four Limited Partnership on behalf of the other partners pursuant to Section 19 of the Limited Partnership Agreement dated March 19, 1985, the undersigned has executed this Certificate of Amendment to Certificate of Limited Partnership of WLP Four Limited Partnership as of this 5th day of April, 1985.
