

ARTICLES OF INCORPORATION

We, the undersigned, being three or more natural persons of full age, at least two-thirds of whom are citizens of the United States or of its territories or possessions, have this day voluntarily associated ourselves for the purpose of forming a private non-profit corporation under the laws of the State of Idaho, and to that end hereby adopt articles of incorporation as follows:

ARTICLE ONE.

Name

The name of the non-profit corporation is "FAITH MINISTRIES, INC."

ARTICLE TWO.

Purposes

The purpose of this non-profit corporation is to fulfill the Great Commission, to wit, to go and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, teaching them to observe all that Jesus commanded his disciples (Matt. 28:18-20).

The means for accomplishing this Great Commission and therefore the purpose of this corporation shall include, but not be limited to, (1) preaching from the Bible (2) teaching from the Bible, (3) distributing Bibles and Christian literature (the latter as defined by the elders), (4) education of children, and (5) individual counseling.

ARTICLE THREE.

Duration

This non-profit corporation shall continue perpetually in existence unless and until the following circumstance

occurs:

(1) A Simple majority of the members vote affirmatively to dissolve the corporation.

#### ARTICLE FOUR.

##### Dissolution

Upon the occurrence of the event set out in Article Three, all property belonging to this non-profit corporation will be sold by the elders and the proceeds from such sale will be given to WYCLIFF BIBLE TRANSLATORS.

#### ARTICLE FIVE.

##### Location
