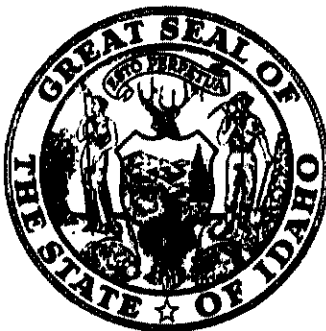
CERTIFICATE OF INCORPORATION OF

The undersigned, in order to form a corporation pursuant to Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is DAYSTAR EXCAVATION, INC.
(hereafter "Corporation").

ARTICLE II

The purposes for which this Corporation is organized are as follows:

1. To engage in Excavation and Construction; and
2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV

The address of the initial registered office of the Corporation shall be 6499 Dry Lake Road, Nampa, Idaho 83686, and the name of its initial registered agent at such address is Lewis Dean.
