ARTICLES OF INCORPORATION

know all MEN By THESE PRESENTS! That we, the undersigned whose names are subscribed hereto, one of whome is a bona fide resident of the State of Idaho, do hereby organize constitute and associate ourselves into a body corporate for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby set forth and declare as follows:

FIRST

That the name of this corporation is "WALTACE BROTHERS, INC."

SECOND

That the purposes for which this corporation is organized are: To carry on and conduct a general automobile and garage business; buy, sell, deal in, lease, distribute, store, repair and manufacture automobiles and motor vehicles of all descriptions and air planes and motor boats of all kinds and their parts and accessories and supplies therefor and all articles and things pertaining thereto or the operation thereof.

To build, own, lease, operate, buy and sell garages and gasoline filling stations and buildings of all kinds.

To carry on a general mercantile business of handling, buying and selling gas, oils, greases, gesolines

and all other petroleum products.

To own, convey, mortgage, hypothecate and incumber both real and personal property and to execute notes and contracts and other instruments in writing and contract indebtedness and pay for the same,

And to do everything necessary or suitable or convenient for the accomplishment of the purposes or any one or more of the purposes herein enumerated or incident thereto.

THIRD

The place where the principal business of this corporation shall be transacted is the City of Boise, Ada County, Idaho,
