ARTICLES OF INCORPORATION

OF .

THE CASCADE JUNIOR CHAMBER OF COMMERCE, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all full aged citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a non-profit cooperative corporation under the laws of the State of Idaho, and to that end do hereby adopt Articles of Incorporation as follows:

ARTICLE I

The name of the proposed corporation shall be "THE CASCADE JUNIOR CHAMBER OF COMMERCE, INC."

ARTICLE II

The purposes of the corporation shall be;

- (a) Civic service through the organized efforts of the young men of the community to promote the welfare of the community and its citizens through active, constructive projects and
- (b) To provide the young men constituting its membership training in leadership and to instill civic consciousness to better their usefulness as citizens.
- (c) To acquire, own, hold, sell, lease, pledge, mortgage or otherwise dispose of any property, real or personal, necessary to the operation of this corporation.
- (d) To borrow money, contract debts, make contracts, and to exercise any and all such powers as a natural person could lawfully make, do, perform, or exercise which may be necessary, convenient or expedient for the accomplishment of any of its objects or purposes, providing the same be not inconsistent with the laws of the State of Idaho.

(e) In general, to manage, operate, and carry on any other business in connection with the foregoing, and to have and exercise all the powers conferred by the State of Idaho upon corporations, formed under Chapter 10 Title 30 of the Idaho Code, and do any or all of the things hereinabove set forth to the same extent as natural persons might or could do.

ARTICLE III

The duration of this corporation shall be peretual.

ARTICLE IV

The principal office for the transaction of the business of this club shall be the Intermountain State Bank, Cascade, Idaho.

ARTICLE V

This corporation is not organized for pecuniary profit nor shall it have any power to issue certificates of stock or declare dividends, but shall issue membership certificates to each member, which certificates cannot be assigned so that the transferee thereof can by such transfer become a member of the association, except by resolution of the Board of Directors and under such regulations as the By Laws prescribe, and no part of it's net earnings shall inure to the benefit of any member, director, or individual. The rights and interests of all members shall be equal.
