JEROME CHAMBER OF COMMERCE, INC., an Idaho non-profit
("Corporation"), hereby restates its Articles of Incorporation originally filed
Secretary of State on the 15th day of April, 1939, with all amendments thereto through the 18th
day of January, 2023, as follows:

ARTICLE I

The name of the Corporation shall be "Jerome Chamber of Commerce, Inc."

ARTICLE II

The purposes of the Corporation are:

1. To foster trade and commerce in the city of Jerome, Idaho, and its surrounding trade area;
2. To protect such trade and commerce from unjust actions or discriminations;
3. To disseminate accurate and reliable information affecting trade and commerce to its members;
4. To promote ongoing communication and cooperation regarding trade and commerce among its members, with businesses and other organizations within its trade area, and with surrounding communities;
5. To promote the advancement and enhancement of the economic vitality of the city of Jerome and its surrounding trade area; and
6. To pursue any other activity that non-profit corporations may pursue under the laws of the state of Idaho, consistent with Section 501(c)(6) of the Internal Revenue Code.

ARTICLE III

The Corporation was organized as a Chamber of Commerce, and will continue in existence under Section 501(c)(6) of the Internal Revenue Code as a Chamber of Commerce. No revenue of the Corporation may inure to the direct benefit of any member of the Corporation.

ARTICLE IV

The name and address of the Corporation's non-commercial registered agent is:

ARTICLE V

The principal business office of the Corporation shall be located within the City of Jerome, Idaho.

ARTICLE VI

The Corporation shall not issue any capital stock, nor shall it have shareholders. The Corporation will have members.

ARTICLE VII

The duration of the Corporation shall be perpetual unless dissolved as provided by law.

ARTICLE VIII

The Corporation has adopted By-Laws which provide for the regulation and management of its affairs. The By-Laws may be amended from time to time, as provided by them.

ARTICLE IX

The number of directors of the Corporation and their terms of office shall be established by the By-Laws of the Corporation.

ARTICLE X

These Restated Articles of the Corporation shall wholly amend and shall replace the existing Articles of Incorporation in their entirety.

ARTICLE XI

Should the Corporation be dissolved for any reason, the assets remaining after its just debts and obligations are paid shall be distributed to another non-profit corporation or business entity located in the state of Idaho then existing under either Section 501(c)(3) or Section 501(c)(6) of the Internal Revenue Code, as determined by its Directors.

CERTIFICATE ACCOMPANYING RESTATED ARTICLES OF INCORPORATION

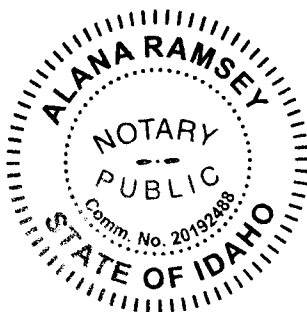
Pursuant to Idaho Code §30-30-706, JEROME CHAMBER OF COMMERCE, INC., an Idaho non-profit corporation ("Corporation") through its Secretary, Eric Bolich, certifies to the Idaho Secretary of State that:

1. The Restated Articles of Incorporation of the Corporation dated the 18th day of January, 2023, including amendments to its previously existing Articles of Incorporation which required approval by its Members and its Board of Directors;
2. The Restated Articles of Incorporation were adopted at a meeting of the Corporation's Board of Directors duly noticed, called, and held on the 18th day of January 2023, at La Hacienda located at 133 West Main Street, Jerome, Idaho. 9 of the current eleven (11) Directors of the Corporation were present. On a vote of 9 for and 0 against the Restated Articles of Incorporation were approved by the Board of Directors;
3. The Restated Articles of Incorporation were also approved at a meeting of the Members of the Corporation duly noticed, called, and held on the 18th day of January 2023, at La Hacienda located at 133 West Main Street, Jerome, Idaho. 196 Members were eligible to vote at the meeting. 38 Members were present at the meeting, either in person or by proxy. The Restated Articles of Incorporation were approved by a vote of 38 for and 0 against.
