The undersigned, acting as the incorporator of a corporation (hereinafter referred to as "Corporation") under the Idaho Business Corporation Act (the "Act"), adopts the following Articles of Incorporation for the Corporation:

____ARTICLE 1. NAME____

The name of the Corporation WOOD FAMILY TRUCKING, Inc.

____ARTICLE 11. PERIOD OF DURATION____

The period of duration of the Corporation is perpetual.

____ARTICLE 111. PURPOSES AND POWERS____

SECTION 1____ The purpose for which the Corporation is organized is: The transaction of any or all lawful business for which corporations may be incorporated under the Act; to do everything necessary, proper, advisable or convenient for the conduct of said business; and to do all other things incident thereto or connected therewith, which are not forbidden by the Act, by other law, or by these Articles of Incorporation.

SECTION 2____ The Corporation shall have and may exercise all powers necessary or convenient to effect its purposes, including but not limited to the statutory powers specified in the appropriate sections of the Idaho Code, as amended and supplemented.

SECTION 3____ The Corporation shall engage in the transportation of general commodities of all kinds, transporting refer trailers, flatbed trailers, pulling double trailers and the doing of any other business and contracting work incidental to or connected with such work. The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from engaging in any lawful act or activity for which a corporation may be organized under the General Corporation Law of the state of Idaho,

____ARTICLE IV. AUTHORIZED SHARES____

SECTION 1____ NUMBERS____ The aggregate number of shares of common stock which the Corporation shall have the authority to issue is 150,000. The stock shall have 1.00 par value.

SECTION 2. DIVIDENDS._____ The holders of the common stock shall be entitled to receive, when and as declared by the Board of Directors, as permitted by the Act, dividends or distributions payable either in cash, in property, or in shares of the capital stock of the Corporation.

SECTION 3. STOCK NONASSESSABLE._____ The private property of the shareholders of the Corporation shall not be subject to the payment of corporate debts to any extent whatsoever, and shares of the Corporation shall not be subject to assessment for the purpose of paying expenses, conducting business, or paying debts of the Corporation

SECTION 4. VOTING POWER._____ The entire voting power for the election of the Directors and for all other purposes shall be vested exclusively in the holders of the common stock, who shall be entitled to one vote for each share of common stock held by them of record.

_____ **ARTICLE V. PREEMPTIVE RIGHTS** _____

Shareholders of the Corporation shall have preemptive and preferential rights of subscription to any shares of stock of the Corporation, whether now or hereafter authorized, or to any obligations convertible into stock of the Corporation, issued or sold, and the Board of Directors in issuing stock of the Corporation, or obligations convertible into stock, shall first offer such issue of stock or obligations to the shareholders of the Corporation.

_____ **ARTICLE VI. REGISTERED OFFICE** _____

The address of the initial registered office of the Corporation is 14990 Hensen Dr Nampa, Id, 83651 and the name of its initial registered agent is John T Wood.

_____ **ARTICLE VII BOARD OF DIRECTORS** _____

The number of Directors of the Corporation shall be as specified in the Bylaws. The number of Directors constituting the initial Board of Directors is one (1), and the name and address of the person(s) who is (are) to serve as Director(s) until the first annual meeting of shareholders or until their successors are elected and shall qualify is:

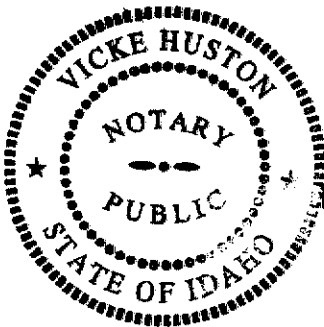
