The undersigned, acting as incorporators of a corporation under the Idaho Business Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is "SUNDANCE PARAFLITE,
INC.".

**SECOND:** The period of its duration is perpetual.
