## ARTICLES OF INCORPORATION (Non-Profit)

The undersigned, in order to form a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State:

**Article 1:** The name of the corporation shall be: **Adoration Fellowship Ministries Incorporated**

**Article 2:** The purpose for which the corporation is organized is exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article 3:** The street address of the registered office is: **100 South Fifth West, Rexburg, Idaho 83440** and the registered agent at such address is: **Reverend Donald L. Hammer**

**Article 4:** The board of directors shall consist of no fewer than three (3) people (unless a church). The names and addresses of the initial directors are:

**Article 5:** The name(s) and address(es) of the incorporator(s): **Rev. Donald L. Hammer, 100 South Fifth West, Rexburg, Idaho, 83440**

**Article 6:** The mailing address of the corporation shall be: **100 South Fifth West, Rexburg, Idaho, 83440**

**Article 7:** The Corporation does not have voting members.

**Article 8:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

**Article 9:** Upon dissolution the assets shall be distributed to any Christian religious, charitable, or educational organization(s) qualified as an IRS 501(c)(3) organization selected by the Board of Directors.
