

ARTICLES OF INCORPORATION  
OF  
THE IDAHO TITLE AND TRUST COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS that the undersigned have associated themselves together for the purpose of forming a private corporation under and by virtue of the laws of the State of Idaho and do declare as follows:-

FIRST.

The name of said corporation is and shall be "The Idaho Title and Trust Company, Limited."

SECOND.

The purposes for which it is formed are as follows:-

1st:- To furnish Abstracts of Title to Real Estate; to Guarantee the title and to make insurances of every kind pertaining to or connected with titles to real estate and to make, execute, and perfect such and so many contracts, agreements, policies and other instruments as may be required therefor.

2nd;- To receive and hold on deposit and in trust and as security, estate real and personal, including the notes, bonds, obligations of States, individuals, companies and corporations, and the same to purchase collect, adjust, and settle, sell and dispose of in any manner without proceedings in law or equity and for such price and on such terms as may be agreed on between it and the parties contracting with it.

3rd;- To act as Trustee, Assignee, Receiver, Guardian, Executor and Administrator and to take, accept and execute Trusts of every description not inconsistent with the laws of the State of the United States and to receive deposits of monies and other personal property and issue its obligations therefor, to invest its funds in and to purchase real and personal securities, and to loan money on real and personal

securities.

4th;- To act as fiscal or transfer Agent of any State, Municipality, Body Politic or Corporation and in such capacity to receive and distribute money transfer, register and countersign certificates of stocks, bonds and other evidences of indebtedness and to receive and manage any sinking fund thereof on such terms as may be agreed upon.

5th;- To take, receive and hold any and all such pieces of real property as may have been or may hereafter be the subject of any insurance made by it under the powers conferred by its charter and the same to grant, bargain, sell, convey and dispose of.

6th;- To purchase and to sell real estate and take charge of same.

7th;- To become security for the payment of all damages that may be assessed and directed to be paid for lands taken in the building of any rail-way or for the opening of streets or roads, or for any purpose whatever where land or property is authorized by law to be taken.

8th;- To become security upon any writ of error or appeal or in any proceeding instituted in any Court in this State in which security may be required.

THIRD.

The place where its principal business is to be transacted is Boise in the County of Ada in the State of Idaho.

FOURTH: °

The term for which it is to exist shall be fifty years from and after the date of filing these articles.

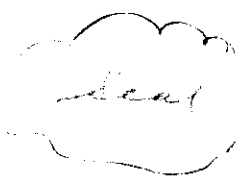
