KNOW ALL MEN BY THESE PRESENTS: That we the undersigned, citizens of the United States of America, of full legal age, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

I.

The name of this corporation is, and shall be "HOPE LUMBER COMPANY, INC." The corporate existence shall be perpetual.

II.

That the purposes for which it is formed are as follows:

To manufacture, re-manufacture and deal in general with all
lumber products, timber products, and allied products of every
kind and nature whatsoever including, without limiting the
generality of the foregoing, the purchase and sale of such products. Said business shall be conducted at Hope, Idaho, or
other towns or places in northern Idaho.

To acquire by gift, grant, purchase, devise, lease or otherwise, both real and personal property necessary or convenient to carry out the purposes of this corporation, and to own, hold, use, enjoy, and dispose of the same in such manner as it may determine.

To sell, lease, mortgage, exchange, encumber, alienate, transfer or convey all or any of the real or personal property of this corporation, at such times, and in such manner as it shall determine.

To borrow money for the carrying out of these purposes, and to issue and execute notes, mortgages, bonds, or other evidence of indebtedness for the same, in such form as it may deem advisable,
