was filed in the office of the Secretary of State on the **Tenth** day of **September**, A. D. One Thousand Nine Hundred **Sixty-two** and is duly recorded on Film No. **120** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Caldwell** in the County of **Canyon** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

ARTICLE I

NAME

The name of this corporation shall be the SNAKE RIVER UNITED FUND, INC.

ARTICLE II

PURPOSE

The purpose or purposes for which it is formed are:

A. To bring together in a united appeal all possible campaigns of community-accepted health, welfare, and recreational agencies, including local, state, and national service organizations.

B. To solicit funds and property for such agencies; to acquire by gift, legacy, devise, purchase, or otherwise, property of every kind and nature, both real and personal, for such agencies; to lease, mortgage, improve, pledge, sell, convey or otherwise dispose of such property.

C. To invest and expend funds, and to distribute funds to such agencies.

D. To create a more general interest in the service of such agencies and in the unified appeal plan.

E. To do all acts and things necessary, convenient, or expedient to carry on the above mentioned purposes.

### ARTICLE III

#### DURATION

The period of existence and period during which it is to continue as a corporation is perpetual.

### ARTICLE IV

#### PLACE OF BUSINESS

### ARTICLE V

#### STOCK

This corporation is organized on a non-stock basis and all proceeds shall be used solely for charitable purposes.

### ARTICLE VI

#### DIRECTORS

The affairs of this corporation shall be directed by a Board of Directors consisting of no fewer than fifteen (15) nor more than one hundred (100) persons, the exact number, within such limitations, to be determined at the annual meeting of the corporation and they shall serve on the Board for a one-year term.
