## **ARTICLES OF INCORPORATION**

**ARTICLE 6: THE PERIOD OF DURATION SHALL BE PERPETUAL.**

**ARTICLE 7: PURPOSES: TO ENGAGE GENERALLY IN THE MOTEL AND RELATED BUSINESSES; TO PLAN, DESIGN AND CONSTRUCT BUILDINGS FOR MOTEL PURPOSES AND TO BUY, SELL AND ACQUIRE THE SAME CARRY ON THE MOTEL BUSINESS AND SUCH ACCOMODATIONS NECESSARY TO ACCOMPLISH SUCH PURPOSES;**

**TO OWN, HOLD, RENT, CONTROL, LEASE, OPERATE, CONDUCT AND ENGAGE IN THE RESTAURANT BUSINESS; AND TO FURNISH, EQUIP AND MANAGE RESTAURANTS, INNS, EATING HOUSES, TAVERNS, CAFES, CABARETS OR PLACES OF ENTERTAINMENT, AND GENERALLY TO DO AND PERFORM EVERYTHING NECESSARY FOR CARRYING OUT THE AFORESAID PURPOSES; AND TO PREPARE, MARKET, IMPORT AND EXPORT FOOD AND FOOD PRODUCTS OF EVERY CLASS AND DESCRIPTION, FRESH, CANNED, PRESERVED OR OTHERWISE, AND TO PREPARE AND SERVE ALL FOOD, BEVERAGES, ALCOHOLIC OR NONALCOHOLIC AND OTHER PREPERATIONS AND REFRESHMENTS OF ALL KINDS;**

**TO ENGAGE IN THE ON-SALE DISPENSING OF ALCOHOLIC BEVERAGES OPERATING AS A BAR, LOUNGE AND RESTAURANT, AND GENERALLY TO PURCHASE OR OTHERWISE ACQUIRE BARS, LOUNGES, RESTAURANTS AND TAVERNS AND TO MANAGE, OWN, HOLD, LEASE, RENT OR SELL SUCH BUISNESS OR BUISNESSES;**

**TO PROMOTE FELLOWSHIP AND EXTEND AQUAINTANCESHIP BY MEANS OF DANCES, MUSICALS AND OTHER KINDRED FORMS OF ENTERTAINMENT;**

**TO ENGAGE GENERALLY IN ANY CAUSES OR OBJECTS SIMILAR TO THE ABOVE MENTIONED IN ORDER TO PROMOTE THE CULTURAL, SOCIAL, LITERARY AND GENERAL WELFARE OF THE COMMUNITY AND THEREBY PROMOTE TOURISM AND THE LOCAL ECONOMY WHEREIN THE CORPORATE ESTABLISHMENTS MAY BE DOING BUISNESS; AND**

**IN ADDITION THE CORPORATION SHALL BE AUTHORIZED TO OWN, BUY, SELL, TRADE, IMPORT OR EXPORT AND OTHERWISE DEAL IN PROPERTY OF ALL KINDS AND DESCRIPTIONS, INCLUDING REAL, PERSONAL INTANGIBLES OR MIXED, AND TO ENGAGE IN ANY AND ALL OTHER LAWFUL PURPOSES, ACTIVITIES OR PURSUITS WHETHER SIMILAR OR DISSIMILAR TO THE FOREGOING AND TO HAVE ALL POWERS ALLOWED BY LAW, INCLUDING THOSE DESRIBED IN THE CORPORATE LAWS OF IDAHO.**

**ARTICLE 8: THE CORPORATION SHALL INDEMNIFY ITS OFFICERS, DIRECTORS, EMPLOYEES AND AGENTS UNDER AND IN ACCORDANCE WITH SECTION 30-1-6 OF THE CORPORATE LAWS AND CODE OF IDAHO.**
