ARTICLES OF INCORPORATION

THE IDAHO ADBILE HOME DEALERS ASSOCIATION, INC.

WE, the undersigned natural persons, each over the age of 21 years, acting as incorporators of a non-profit co-operative association, pursuant to the provisions of Chapter 10, Title 30 of the Idaho Code, adopt the following Articles of Incorporation for the Idaho Mobile Home Dealers Association, Inc.:

The name of the co-operative association shall be, and is, The Idaho Mobile Home Dealers Association, Inc.

II

The period of its duration shall be, and is, perpetual.

III

The purposes for which the co-operative association is organized are:

- A. To promote a better relationship among mobile home dealers, and to unite them in the bonds of good fellowship and closer understanding.
- 3. To promote and encourage the ownership and use of mobile homes.
- C. To uphold the principals of good government, and to educate and inform the membership of the association and the public generally, concerning any and all laws and ordinances, and proposed laws and ordinances, affecting the sale, ownership, use or enjoyment of mobile homes, or trailer houses, or affecting the business of dealing in mobile trailer homes in any way whatever.
- D. To carry on any and all activities within the scope and purpose of this organization.
- E. To lease, rent, purchase, own, pledge, mortgage, hypotecate, sell, and convey such personal and real property in the name of the association as may be necessary in the management or operation of the affairs of the association.

IV

Membership certificates shall be issued to each member thereof and the rights and interests of all members shall be equal.

The membership of the co-operative association shall be determined by rules, regulations, and by-laws of the corporation.

The Board of Directors shall consist of four (4) members, three (3) of whom shall also be the president, the vice-president, and the secretary-treasurer, and each of the directors shall serve for a term of one year. In all elections, each member of the co-operative association shall have one vote.

The method of operation and the regulation of the business affairs of the co-operative association shall be governed by the by-laws of the association and shall be under the control of the Board of Directors.
