REGAN, President and Secretary, respectively, of MERRILL LYNCH, PIERCE, FENNER & SMITH INCORPORATED, a corporation organized and existing under the General Corporation Law of the State of Delaware, the Certificate of Incorporation of which was filed in the office of the Secretary of State of Delaware on November 10, 1958 and filed for recording in the office of the Recorder of Deeds for New Castle County, Delaware on November 10, 1958 and Certificates of Amendment of the Certificate of Incorporation of which were filed in said office of the Secretary of State on January 5, 1959, October 30, 1959 and April 13, 1960, and filed for recording in said office of the Recorder of Deeds for New Castle County, Delaware on January 5, 1959, October 30, 1959 and April 13, 1960, respectively,

Do HEREBY CERTIFY:

That the Board of Directors of said corporation at a meeting held on April 10, 1962 duly adopted a resolution authorizing and directing an increase in the authorized number of shares of Non-Voting Common Stock of the corporation from 1,540,000 shares to 1,580,225 shares, in accordance with the provisions of section 151 of The General Corporation Law of the State of Delaware, which resolution is as follows:

RESOLVED, that, pursuant to authority vested in the Board of Directors of the Corporation in accordance with Section 1 of Article IV of the Certificate of Incorporation, as amended, the authorized number of shares of Non-Voting Common Stock of the Corporation is hereby increased from 1,540,000 shares to 1,580,225

shares by hereby designating and fixing, out of the 450,050 shares of common stock of the Corporation which are authorized to be issued as shares of Voting Common Stock or shares of Non-Voting Common Stock, 40,225 shares as shares of Non-Voting Common Stock, with the powers, preferences and rights and the qualifications, limitations or restrictions thereof set forth in Section 3 of Article IV of the Certificate of Incorporation, as amended.
