




**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

SECRETARY OF STATE

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is L.W. HOLDINGS, INC.

ARTICLE II

The period of the corporation's duration is perpetual.

ARTICLE III

The purposes for which the corporation is organized are to transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The total authorized number of par value shares of stock is Five Thousand (5,000). The aggregate par value of the total authorized number of par value shares is Five Hundred Dollars (\$500.00). There are no shares without par value.

ARTICLE V


