ARTICLES OF AMENDMENT

Amendment of Articles of Incorporation of

Emmanuel Baptist Church of Mountain Home, Idaho, Incorporated,
a nonprofit corporation organized under the laws of the

State of Idaho, executed by Dick Olney, of 335 Dutton

Drive, City of Mountain Home, County of Elmore, its president,
and Jimmy Swails, of 1115 West 24th South, City of Mountain

Home, County of Elmore, its secretary.

The Corporation was organized on the 12th day of November, 1982.

The Corporation, on the proposal of its Board of Trustees (Directors) by Resolution duly adopted by said Board of Trustees (Directors) setting forth the proposed amendment and directing that the same be submitted to a vote of the members entitled to vote in respect thereof at a designated meeting of such members, and on the adoption thereof by said members at said meeting as provided by law, does hereby, by Dick Olney, its president, and Jimmy Swails, its secretary, execute and acknowledge the following:

FORMAL RESOLUTION OF AMENDMENT--ADDITION OF ARTICLE OR SECTION

WHEREAS, the Board of Trustees (Directors) of Emmanuel Baptist Church of Mountain Home, Idaho, Incorporated, desire to amend the Articles of Incorporation to provide:

To show that the Corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes;

To show that the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income taxes under Section 501(c)(3) of the Internal Revenue Code;

To show that upon dissolution of this Corporation any remaining assets after payment of all debts shall be distributed to a nonprofit fund which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code;

To show that this Corporation is not organized for profit, and no part of the earnings shall inure to the benefit of any private shareholder.

RESOLVED, That the Articles of Incorporation be, and they are hereby amended by adding thereto, immediately after Article III, Section 1, and immediately before the original Section 2, the following new Section Numbers: Sections 2,3,4, and changing the original Section 2 to Section 5; and immediately after Article VI and replacing the original Article VII with the following new Article VII: DISSOLUTION and changing the original Article VII: AMENDMENTS to Article VIII: AMENDMENTS so that the Articles of Incorporation as amended, shall read as follows:

ARTICLES OF INCORPORATION OF THE EMMANUEL BAPTIST CHURCH OF MOUNTAIN HOME, IDAHO, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are of full age and citizens of the United States of America, and residents of the State of Idaho, do voluntarily associate ourselves for the purpose of forming a religious corporation under the laws of the State of Idaho, and particularly under Chapter 11 of Title 30 of the Idaho Code, and we do hereby make, subscribe, and execute the following Articles of Incorporation, and we do hereby certify:

ARTICLE I: NAME AND LOCATION

The name of this Corporation is: EMMANUEL BAPTIST CHURCH OF MOUNTAIN HOME, IDAHO, INCORPORATED, and the mailing address is Post Office Box 79, Mountain Home, Idaho 83647; the location of this Corporation is at the Odd Fellows Hall, 159 North Third East, City of Mountain Home, County of Elmore,

State of Idaho; the Contact Person (Registered Agent) for this Church is Richard P. Olney, P. O. Box 79, Odd Fellows Hall, 159 North Third East, Mountain Home, Idaho 83647; Telephone: 208-587-4728.

ARTICLE II: DURATION

The period of duration of this nonprofit corporation shall be perpetual.

ARTICLE III: PURPOSES

The purposes for which this Corporation is formed are and shall be:

Section 1. The general purpose and plan of operation of this Corporation shall be to establish the Emmanuel Baptist Church in Mountain Home, County of Elmore, State of Idaho, to buy, manage and own and hold real and personal property necessary and proper for placing of public worship, schools and partial housing, carry on additional charitable and missionary work under the rules and regulations of the Constitution as adopted by the congregation of the above-named Church, said Constitution is in harmony with these Articles of Incorporation under the laws of the State of Idaho.

Section 2. This Corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Section 3. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code.

Section 4. This organization is not organized for profit, and no part of the earnings shall inure to the benefit of any private shareholder.

Section 5. To have all of those certain powers granted to relative corporations under and by virtue of the laws of the State of Idaho, and do each and all things necessary, suitable and proper to the accomplishment of the purposes hereinabove set forth.

ARTICLE IV: MEMBERSHIP

No capital stock shall be issued by this Corporation but in lieu thereof, membership certificates or cards may be issued pursuant to the Constitution and By-Laws of said Corporation.

ARTICLE V: BOARD OF TRUSTEES (DIRECTORS)

Section 1. The operation of the affairs of this Corporation shall be vested in a Board of Trustees (Directors) to consist of four (4) members, to be elected in form and manner prescribed by the Constitution and By-Laws of this Corporation, and these heretofore elected pursuant to notice heretofore given shall constitute the Board of Trustees (Directors) until their successors are duly elected and qualified;

That said Board shall only act for the Church and any actions are to be carried out only after a favorable vote from the majority of the membership of the Church present in a regular or called business meeting of the Church. Said Board shall furthermore have the power to transact any business of this Corporation, including the right to create a trust fund of personal property or real property and provide for the management thereof, and shall have all the powers granted to a Board of Trustees (Directors) under and by virtue of the laws of the State of Idaho;

ARTICLE VI: ELECTION OF TRUSTEES (DIRECTORS)

The Trustees (Directors) hereinabove named, and each duly elected by unanimous vote, were present at a meeting duly held at the Emmanuel Baptist Church, Odd Fellows Hall, 159

North 3rd East, Mountain Home, Idaho, on the 17th day of October, 1982, at the hour of 8:00 P.M. o'clock pursuant to notice duly given for the purpose of electing a Board of Trustees (Directors) of four (4) members and take such steps as may be necessary to incorporate the EMMANUEL BAPTIST CHURCH under the laws of the State of Idaho, and transact further business in said notice.

ARTICLE VII: DISSOLUTION

Upon the winding up and dissolution of this Corporation, after paying or adequately providing for the debts and obligations of the Corporation, the remaining assets shall be distributed to the Utah-Idaho Southern Baptist Convention, which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE VIII: AMENDMENTS

These Articles may be amended in the manner provided by statute at the time of amendment and in harmony with the Constitution and By-Laws of the Church.
