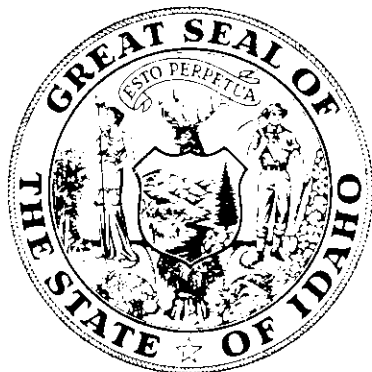

ARTICLES OF INCORPORATION OF B. D. SOLAR CO.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is B. D. Solar Co.

SECOND: The following amendments of the Articles of Incorporation were unanimously adopted by the shareholders of the corporation on June 8th, 1987, in the manner prescribed by the Idaho Business Corporation Act:

ARTICLE I. The name of the Corporation shall be B. D. Contractors, Inc.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was three (3); and the number of shares entitled to vote thereon was three (3). Three (3) shares were voted in favor of the resolution and no shares were voted against the resolution.

FOURTH: The original Articles of Incorporation are confirmed in all other respects.
