*ARTICLES OF INCORPORATION

OF

IDAHO FEDERATION OF SQUARE, AND ROUND DANCE CLUBS, INC.

KNOW ALL MEN BY THESE PRESENTS That we, the undersigned, all residents 6 of the State of Idaho, do hereby voluntarily associate ourselves together for the purpose of forming and organizing a non-profit, benevolent and charitable organization under and by virtue of the provisions of Chapter 11, Title 30 of the Idaho Code, and hereby make, subscribe and execute the following Articles of Incorporation of said association, and we do hereby certify:

ARTICLE I.

NAME

That the name of this corporation is IDAHO FEDERATION OF SQUARE AND ROUND DANCE CLUBS, INC.

ARTICLE II.

Purposes and Powers

This corporation is a non-profit organization and is formed for benevo-17 lent and charitable purposes and especially as follows:

To promote and foster square dancing and related activities in the State of Idaho.

ARTICLE III.

Place of Business

That the principal place of business of this corporation shall be in the City of Boise, County of Ada, State of Idaho.

ARTICLE IV.

Term of Existence

The time for which said corporation shall be created shall be perpetual.

ARTICLE V.

Capital Stock

This corporation does not have and shall not have any capital stock, and neither shall it issue to its members certificates representing capital stock, 29 and this corporation shall not be operated for a pecuniary profit.

ARTICLE VI.

Directors

These articles may be amended in any respect at any regular meeting of this corporation by a vote of the majority of the quorum attending such meeting; provided that public notice of intention to amend the Articles of Incorporation shall have been given by publication at least once a week for four weeks in a newspaper published in the County wherein such meeting is to be held, such notice to designate the regular meeting at which it is intended to vote on the proposition of amending said Articles of Incorporation, and shall state the manner in which it is intended to amend the Articles of Incorporation.
