

ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS, That we, J. A. Armstrong, Wm. Wagner, P. R. Kartzke, H. R. Schoenthal, John D. Nims, and D. A. L'Harisson, have associated ourselves together and by these presents do hereby associate ourselves together as a corporation under the name and style of

THE JEROME CEMETERY ASSOCIATION, LIMITED,

for the purpose of becoming a body corporate and politic under and by virtue of the laws of the State of Idaho and in accordance with the provisions of the laws of said State, we do hereby make, execute and acknowledge in triplicate this certificate in writing of our intention to become a body corporate under and by virtue of said laws.

I. The corporate name and style of this corporation shall be

THE JEROME CEMETERY ASSOCIATION, LIMITED.

II. The purposes for which it is formed are: To acquire, own, survey, lay out, and maintain one or more cemeteries within the County of Lincoln, State of Idaho; to sell lots therein for burial purposes; to purchase, acquire, own, sell, convey, and dispose of such real and personal property as may be necessary to accomplish said purposes; and in general to do and to perform any act or acts which may be necessary for the carrying out of the purposes of this corporation.

III. The principal place of business and business office shall be located in the town of Jerome, Lincoln County, Idaho.

IV. The time of the commencement of the corporation shall be the date of the filing of these articles of incorporation in the office of the secretary of state of the State of Idaho and the term for which it is to exist shall be fifty years from and after the date of said filing and subject to renewal as provided by said law.

V. The capital stock of said corporation is One Thousand Dollars (\$1,000.00) to be divided into one hundred shares of Ten Dollars (\$10.00) for each share.

VI. The amount of said capital stock which has been actually subscribed is:

VII. The affairs and management of said corporation are to be under the control of six directors and Paul R. Kartzke, J. A. Armstrong, Wm. Wagner, H. R. Schoenthal, John D. Nims, and D. A. L'Herisson are hereby selected as said directors to manage the affairs and concerns of said corporation for the period of and until the annual meeting to be held in the year 1915, or until their successors are duly elected and qualified.
