KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, being a natural citizen of the United States and of full age and majority, have this day and do hereby voluntarily associate myself together for the purpose of forming a corporation under the laws of the State of Idaho, and I do hereby certify:

ARTICLE I.

The name of this corporation shall be **HESS VETERINARY SERVICE, WEST, P.C.**

ARTICLE II.

The purposes and objects for which this corporation are formed are:

1. To generally engage in, do and perform all types of veterinary services and other services related thereto as permitted or authorized pursuant to the provisions of the Idaho Professional Service Corporation Act and amendments thereto.

ARTICLE III.

This corporation shall have a perpetual existence.

ARTICLE IV.

The total number of shares which the corporation is authorized to issue is One Hundred Thousand (100,000). The aggregate par value of such shares is zero (-0-) and the par value of each share is zero (-0-).

ARTICLE V.

There are no provisions granting or denying preemptive rights. However, the corporation may not issue any capital stock to anyone other than an individual duly licensed to practice veterinary medicine in the State of Idaho. All stockholders shall be governed by the Professional Services Corporation Act of Idaho.

ARTICLE VI.

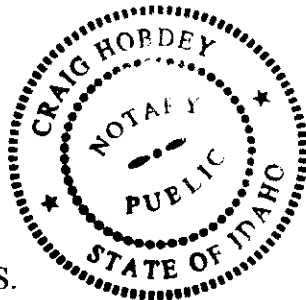

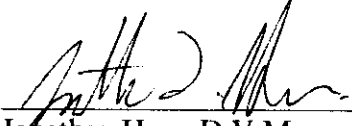

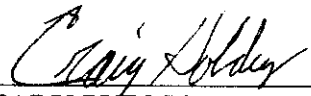
