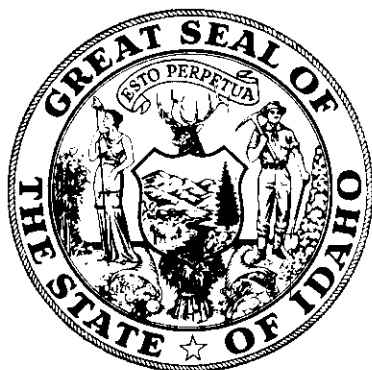

ARTICLES OF AMENDMENT
ELDERWOOD, INC.
An Idaho Corporation

THE SHAREHOLDERS of the Corporation adopted the following
AMENDMENT to the ARTICLES OF INCORPORATION at a meeting held for

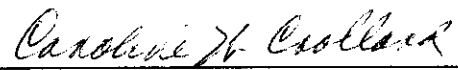
