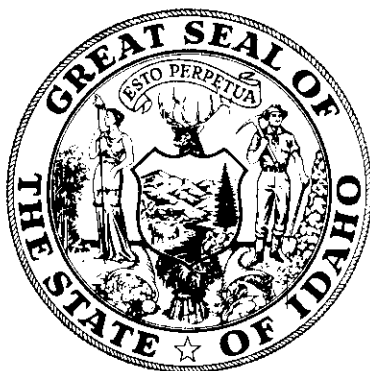

INCORPORATION

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is ENGINEERED STRUCTURES OF SOUTHERN IDAHO INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on October 10, 1980 in the manner prescribed by the Idaho Business Corporations Act:

That paragraph I of the Articles of Incorporation of Engineered Structures of Southern Idaho Inc., be amended as follows: That the name of this corporation is TOM NICHOLS CONSTRUCTION INC.


THIRD: The number of shares of the corporation outstanding at the time of such adoption was 3500 and the number of shares entitled to vote thereon was 3500.


