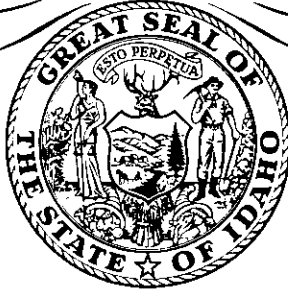

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

THE TITLE INSURANCE COMPANY FOUNDATION, INC.

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **twenty-sixth** day of **October,** 19 **59,** original articles of amendment, as provided by Section **§ 30-1103, 30-1105, Idaho Code,** **deleting entire provisions of Article II, and inserting in lieu thereof new Article II, pertaining to the purposes and objects of the corporation,**

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No. **109** of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF TITLE INSURANCE COMPANY FOUNDATION, INC.

* * * * *

BE IT KNOWN, That we, the undersigned, President and Secretary,
respectively of Title Insurance Company Foundation, Inc., do hereby certify
and 30-1105,
in accordance with the provision of Sections 30-1103 ~~I~~. C., as follows, to-wit:

I

That a special meeting of the member of Title Insurance Company
Foundation, Inc. was held at 711 Bannock Street, Boise, Idaho, on the 1st day
of October 1959, pursuant to notice given as provided by law, at which meeting
all members were present in person or by proxy.

II

That at said meeting all the members of said corporation voted in
favor of amending Articles of Incorporation by including a new article to be
numbered Article II and voted in favor of said resolution, unanimously adopting
the following:

"BE IT RESOLVED By the Directors of the Title Insurance
Foundation, Inc., met according to due notice, that the Articles
of Incorporation of the Company be changed and amended by
amending Article II thereof by deleting from the Articles of In-
corporation the entire provision of Article II and inserting in
place thereof the following Article II.

ARTICLE II

"The purposes and objects of this corporation for which it
is organized and shall be operated exclusively, are: religious,
charitable, scientific, literary and educational, and to these
ends it is authorized to accept, hold, administer, invest and dis-
burse funds, both principal and interest, as may from time to
time be given to it by any person, persons or corporations, to
receive gifts and make financial and other types of contributions
and other assistance to such purposes and organizations devoted
thereto, and in general to do all things that may be necessary and
useful to accomplish these purposes hereinabove set out. All of
the assets and earnings of this corporation shall be used exclusively
for these purposes hereinabove set out, including the payment of ex-
penses incidental thereto, and corporation is expressly prohibited
from carrying out any propaganda or attempts to influence legis-
lation, which acts are declared to be ultra vires and contrary to

the purposes of this corporation; and in particular, by way of illustration and not of limitation of the general powers, to devote the funds and earnings of said corporation within said general terms of the following specific purposes among others:

" (1) To establish and maintain aids, contributions scholarships, fellowships, and gifts in support of privately endowed or public institutions of education, but only to those which are tax exempt under the Internal Revenue Law, to the end of providing scholarships and loans or otherwise so as to assist worthy young men and women of slender means or merit to obtain an education, and children of employees of the Title Insurance Company and its subsidiaries shall be included in the general class who will be eligible, but such children shall not have any priority over other persons qualifying under this clause, nor shall such children be considered on the basis of the position, length of service or other measure of employment with said company or its subsidiaries. To the extent that any aid is given to such person is other than an outright gift, the same shall be made as a loan with interest to be paid following the graduation of the person, and during the period of repayment of the loan, which repayment term shall not be more than eight years after graduation.

" (2) To give financial and other types of aid assistance and contribution to units of federal, state or local government where the same is exclusively used for public purposes; to corporations, trusts, community chests, or funds organized and operated exclusively for said purposes and said organizations are tax exempt by the United States Government therefor.

"No provision of this Article Second shall be amended without the unanimous consent of the members of the Board of Directors of this corporation."

That John B. Bell and J. M. Epeneter are President and Secretary, respectively, of Title Insurance Company Foundation, Inc. and are Chairman and Secretary respectively of the meeting of the members; that the Articles of Incorporation were amended by adding Article II, as hereinabove set forth, at said meeting, and the company has caused this certificate of Articles of Amendment to be executed and verified by its President and Secretary, John B. Bell and J. M. Epeneter, as by law provided pursuant to the resolution hereinabove set forth.
