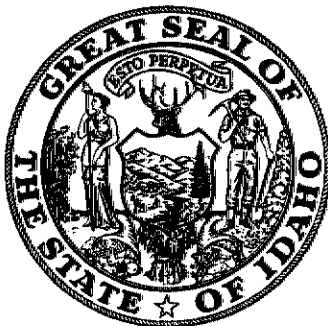

signed natural persons of lawful age and citizens of the United  
States, for the purpose of forming a corporation pursuant to the

do hereby certify as follows:
