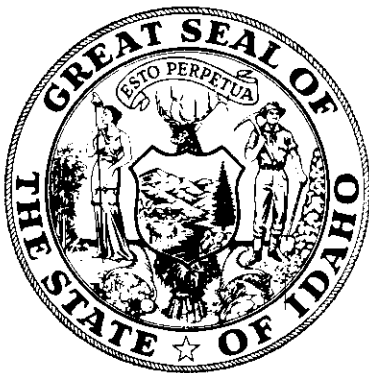

ARTICLES OF AMENDMENT

OF

29 FEB 1989 8 56

THE SPRINKLER SHOP, INC.

A. The name of the Corporation is THE SPRINKLER SHOP, INC.

B. Article V is amended to read as follows:

The Total authorized number of shares of this corporation shall be 2,000 shares with a par value of \$100.00, all having the relative rights, voting powers, preferences and restrictions on the sale and transfer of the same as set out in the By-Laws of the Corporation.

C. This amendment was adopted by the shareholders on July 1, 1988.

D. There were One Hundred Eight (108) shares of common stock outstanding and entitled to vote and no other classes of stock are authorized.

E. One Hundred Eight (108) shares were voted for the amendment and no shares against.


F. The issued shares have been treated as if they were the shares described in this amendment. Confusion over the contents of the original articles of incorporation have prompted the necessity of this amendment. The issued shares will not, therefore, be effected by the amendment.
