These ARTICLES OF AMENDMENT OF ROCK CREEK LICENSE, INC., an Idaho corporation (the "Corporation"), dated April 17, 1989, are written for the purpose of changing the name and the purpose of the Corporation.

RECITALS

- A. The sole shareholder of the Corporation is Bonneville Pacific Corporation, a Delaware corporation (the "Shareholder").
- B. The shareholder owns 100 shares of no par value common stock, said stock being the only class of stock issued by the corporation, and said number of shares being all of the issued and outstanding shares of the Corporation.
- C. On April 17, 1989 a meeting of the shareholder of the Corporation was held pursuant to Waiver of Notice executed by the Shareholder in accordance with and pursuant to the By-Laws of the Corporation.
- D. At the Meeting of the Shareholder held April 17, 1989, the following amendments were adopted by the Shareholder, with the Shareholder casting votes equal to the number of shares of common stock owned by the Shareholder, i.e., 100 votes for 100 shares of common stock, in favor of the following amendments:

BASED UPON THE FOREGOING, and as verified below, the Articles of Incorporation of Rock Creek License, Inc. as filed with the Secretary of State of Idaho are hereby amended as follows:

Article I is amended in its entirety to read:

Article II, paragraph A is amended in its entirety to read:

ARTICLE II

PURPOSES AND POWERS

The purposes for which this corporation is formed are:

A. To hold the stock of corporations which own or have an interest in hydroelectric and cogeneration projects in the States of Idaho and Utah.

Except as amended hereby, the Articles of Incorporation of Rock Creek License, Inc. remain in full force and effect.


