KNOW ALL PERSONS BY THESE PRESENTS: that we, the undersigned, all residents of the State of Idaho, and citizens of the United States of America, over the age of 21 years, for the purpose of forming a nonprofit corporation pursuant to Chapter 3, Title 30, Idaho Code, for the purpose expressed herein, do hereby adopt the following Articles of Incorporation:

#### ARTICLE I

The name of this corporation is, and shall be, the Idaho Business Owners Association, Inc., an association organized in accordance with Federal and State regulations.

## ARTICLE II

The location and post office address of the initial registered office of said corporation shal be 1363 Sunrise Rim, City of Boise, County of Ada, State of Idaho, 83705 and the initial registered agent shall be Edwin C. Zollinger, 1363 Sunrise Rim, Boise, Idaho, 83705.

## ARTICLE III

The Corporation shall have perpetual existence.

#### ARTICLE IV

The purposes and objectives of this association are:

- 1.- To advance the interests of Businesses in the State of Idaho.
- 2.- To work toward improving the economic state of affairs in the State of Idaho, by providing information and referral services to businesses through printed, electronic and social media.
- 3.- To coordinate, cooperate and communicate with all public and private agencies and organizations whose programs touch businesses to help the State of Idaho and its business communities grow and progress into the future.
- 4.- To identify special needs, problems and barriers facing businesses and work for quick and positive measures to elimanate these obstacles.
- 5.- To research and find newer and better ideas to help improve the economy of our State, by looking into other communities nation wide.

#### ARTICLE V

This is a nonprofit corporation and is formed without any purpose of pecuniary profit, and there shall be no pecuniary profit for the corporation, its members, or its officers. There shall be no capital stock. Monthly dues are provided for in the By-Laws of the Association. The corporations management of its affairs shall be vested in its Board of Directors. The corporation shall comply with applicable provisions of Sections 501(a) and 501(c)(6) of the Internal Revenue Code of the United States of America.

#### ARTICLE VII

In the absence of rules in these Ariticles of Incorporation or in the By-Laws of this Association, the proceedings of the Board of Directors meetings, as well as all other Association meetings, committees, etc., shall be conducted in accordance with established parlimentary procedure.

# ARTICLE VIII

DISSOLUTION: upon dissolution of this corporation by operation of law or otherwise, all assets of the corporation shall be distributed to a government body or a nonprofit corporation or corporation with like objectives and with tax exempt status under Sections 501 (c)(6) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.

#### ARTICLE IX

The private property of the members of the corporation shall not be subject to the payment of corporate debts and no member, Director or Officer shall become individually liable or responsible for debts or liabilities of the corporation.

#### ARTICLE X

MON-DISCRIMINATION: The Idaho Business Owners Association is obligated and will comply with the Civil Rights Act of 1964, and will assure that no person shall on grounds of race, color, creed, sex, national origin, handicap, age, or political affiliation, be excluded from participating in, be denied the benifits of, or be otherwise subject to discrimination under the programs of the Association or activities relating to the programs of the Association.

## ARTICLE XI

- SECTION A- The Articles of Incorporation may be amended at any regular or special meeting of the Idaho Business Owners Association at which there is a quorm, by a two-thirds (2/3) vote of the regular members present.
- SECTION B- No amendment shall be put to vote, unless written notice shall have been mailed to each member of the Association at least two (2) weeks previous to the meeting at which the amendment is to be voted on, said notice to state the proposed amendment.
