ARTICLES OF INCORPORATION OF RECREATION RENTALS, INC.

KNOW ALL MEN BY THESE PRESENCE:

The Undersigned, acting as Incorporator under the Idaho

Business Corporation Act, adopts the following Articles of Incorporation:

 $\underline{\mathtt{SECTION}\ \mathtt{ONE:}}$ The name of the Corporation is RECREATION RENTALS, INC.

SECTION TWO: The period of its duration is perpetual.

SECTION THREE: CORPORATE PURPOSES:

To purchase, sell, rent as Lessor or Lessee, repair, and deal generally in new and used marine products of every variety including, but not limited to power boats, individual water craft and to purchase, sell, rent as Lessor, and deal generally in and with furnishings, accessories and parts for such products.

To own, hold, rent, lease, manage, encumber, improve, exchange, collect rents; and in general to have and exercise all powers, rights and privileges necessary and incident to carrying out properly the object above mentioned.

To carry on any business whatsoever that this Corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interests of this Corporation, and to have and to exercise all powers conferred by the laws of the State of Idaho on corporations formed under the laws pursuant to which and under which this Corporation is formed, as such laws are now in effect or may at any time hereafter be amended, and to do any and all things here and above set forth to the same extent and as fully as natural persons might or could do, either alone or in connection with other persons, firms, associations, or corporations and in any part of the world.

SECTION FOUR: STOCK:

The aggregate number of shares which the Corporation shall have authority to issue is 3,000 shares of common stock at the par value of \$1.00 per share.

SECTION FIVE: CORPORATION REGULATIONS:

The internal affairs of RECREATION RENTALS, INC., shall be regulated by such by-laws as may be provided for the Corporation and in addition shall be regulated in accordance with the provisions of the Idaho Business Corporation Act, Section 30-1-23(A).

SECTION SIX: REGISTERED OFFICE:

The address of the initial registered office of RECREATION RENTALS, INC., is 1850 North Main, Pocatello, Idaho 83201, and the name of its initial registered agent is JAMES L. HERZOG.

SECTION SEVEN: CORPORATE DIRECTOR:

The number of directors constituting the initial board of directors of RECREATION RENTALS, INC., is one (1). This director shall serve as director of the Corporation until the first annual meeting of the shareholders or until his successor or successors is/are elected and qualified.
