ARTICLES OF INCORPORATION

U. S. SUITES OF IDAHO, INC. SECRETARY OF STATE

The undersigned hereby executes the following Articles of Incorporation for the purpose of forming a corporation under the Idaho Corporation Act.

ARTICLE I

Name and Duration

The name of the corporation is U.S. SUITES OF IDAHO, INC., and its existence shall be perpetual.

II

Purpose

This corporation shall be organized for the purpose of engaging in the business of furnishing and subleasing residential executive suites and any other lawful business permitted under the Idaho Corporation Act.

ARTICLE III

Authorized Capital Stock

The corporation is authorized to issue, in the aggregate, fifty thousand (50,000) shares of a single class of stock, all without par value.

ARTICLE IV

No Preemptive Rights

Shareholders of this corporation shall have preemptive rights to acquire additional shares issued by the corporation.

ARTICLE V

Director Liability

A director of the corporation shall not be personally liable to the corporation or its shareholders for monetary damages for conduct as a director, except for liability for the director

•

for (i) any breach of the director's duty of loyalty to the corporation or its stockholders, (ii) acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) conduct provided for under Section 30-1-48, Idaho Code, (iv) for any transaction from which the director derived an improper personal benefit. If the Idaho Corporation Act is amended to authorize corporate action further eliminating or limiting the personal liability of directors, then liability of a director of the corporation shall be eliminated or limited to the fullest extent permitted by the Idaho Corporation Act, as so amended. Any repeal or modification of the foregoing paragraph by the shareholders of the corporation shall not adversely affect any right or protection of a director of the corporation existing at the time of such repeal or modification.

ARTICLE VI

Indemnification

The corporation shall indemnify its directors against all liability, damage, or expense resulting from the fact that such person is or was a director, to the maximum extent and under all circumstances permitted by law.

ARTICLE VII

Amendment

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation in any manner now or hereafter permitted by statute. All rights of shareholders of the corporation and all powers of directors of the corporation are granted subject to this reservation.

ARTICLE VIII

Initial Directors

The initial Board of Directors of this corporation consists of one (1) director. The name and address of the director is as follows:
