ARTICLES OF INCORPORATION

OF

SANDPOINT TRUSS, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS that the undersigned, citizens of the United States of America, of full legal age, do this day proceed for the purpose of forming a corporation under the laws of the State of Idaho, and to that end, we hereby make Articles of Incorporation, as follows:

ARTICLE I:

The name of this corporation is, and shall be SANDPOINT TRUSS, INCORPORATED.

ARTICLE II:

This corporation is formed for broad purposes, which are as follows:

1. To acquire by purchase, lease or otherwise, and to improve and develop real property. To erect dwellings, apartment houses and other buildings, private or public, of all kinds, and to sell or rent the same. To lay out, grade, pave and dedicate roads, streets, avenues, highways, alleys, paths, walks, parks and playgrounds. To buy, sell, mortgage, exchange, lease, let, hold for investment, use and operate real estate of all kinds, improved or unimproved, and any right or interest therein.

2. To purchase or otherwise acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage, or otherwise dispose of, and to invest, trade and deal in and with real property, and any and all interests therein.

3. To build truss rafters, houses or other buildings of every kind and character, either for sale or lease or on contract or otherwise; to lay out, subdivide, resubdivide and plat tracts of land and sell the same, either by such subdivision or resubdivision; and to improve lands laid out, subdivide or resubdivide, grade, oil and improve streets, alleys, parks and other places, and sidewalk, curb and otherwise improve the same, and construct and maintain and operate sewers and any and all other conveniences and matters in connection therewith.

4. To borrow money, to issue bonds, debentures, notes and other obligations of this corporation from time to time, for any of the objects or purposes of this corporation, and to mortgage, pledge, hypothecate, and/or convey in trust, any or all of its property to secure payment thereof.

5. To enter into, make, perform and carry out constructions and maintenance contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality, state or government, or any subdivision, district or department thereof.

6. To have offices, conduct its business and promote its objects within and without the State of Idaho, in other states, the District of Columbia, the territories and colonies of the United States, and in foreign countries, without restrictions as to place or amount.

7. The several clauses contained in this statement of purpose shall be construed as both purposes and powers, and the statement contained in each clause shall be in no wise limited

or restricted, by reference or inference from the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

ARTICLE III:

The corporation existence shall be perpetual.

ARTICLE IV:

That the place where its principal place of business and registered office is physically located is 4200 McGhee Rd.. The registered agent shall be DENVER L. COPAS. The corporation's mailing address is 4200 McGhee Rd., Sandpoint, ID

ARTICLE V:

The corporation shall have the authority to issue 10,000 shares of common stock of a par value of \$1.00 per share.

ARTICLE VI:

That the amount of the capital stock which has actually been subscribed is two thousand (2,000) shares for \$2,000.00. The following are the names of the persons and the addresses of each of the incorporators and a statement of the number of share subscribed by each:
