## ARTICLES OF INCORPORATION OF PIONEER MAINTENANCE, INC.

The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

#### ARTICLE I

The name of the corporation is Pioneer Maintenance, Inc. (hereafter "Corporation").

#### ARTICLE II

The purposes for which this Corporation is organized are as follows:

- 1. To engage in cleaning and maintenance ; and
