

Articles of Incorporation of "The White Mercantile Co.Ltd.

Know all men by these presents, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho. And we hereby certify:

First. That the name of said corporation of the White Mercantile Company, (Limited)

Second. That the purposes for which it is formed are to carry on the business of mercantile buying and selling goods, merchandise, hardware, clothing of all kinds, buying and selling ties, telegraph poles of all kinds, and dealing in lumber, shingles lath in the State of Idaho.

Third. That the place where its principal business is to be transacted shall be the town of Naples, In Kootenai County, State of Idaho.

Forth. That the term for which it is to exist is twenty years from and after the date of its incorporation.

Fifth. That the number of its directors shall be five, and that the names and residences of those who are appointed for the first year are:
