OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is "SANDPOINT SPEEDY AUTO GLASS, INC."

SECOND: The period of its duration is perpetual.
