WOOD RIVER ELK TRUST, INC.

I, the undersigned natural person of the age of 18
years or more, acting as incorporator of a nonprofit
corporation under the Idaho General Business Corporations
Act, adopt the following Articles of Incorporation for such
corporation:

ARTICLE I

The name of the corporation shall be WOOD RIVER ELK TRUST, INC., and the corporation shall be a nonprofit corporation.

ARTICLE II

The nonprofit corporation shall exist perpetually, unless sooner dissolved or disincorporated according to law.

ARTICLE III

The purpose or purposes for which the corporation is organized shall be charitable and to engage in the care, feeding and preservation of elk.

a. The "Corporation" is constituted to attract substantial support from contributions; directly or indirectly, from a representative number of persons and businesses and has not been formed for pecuniary profit or financial gain.

- b. Upon dissolution, the "Corporation's" assets will be distributed for one or more exempt purposes under Section 501 (c) (3) of the Internal Revenue Code.
- The "Corporation" is organized exclusively c. for religious, charitable, scientific, literary, and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code. No substantial part of the activities of the "Corporation" shall be carrying on propaganda, or otherwise attempting to influence legislation, and the "Corporation" shall not participate or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for political office. Notwithstanding anyother provision of these Articles of Incorporation, the "Corporation" shall not carry on anyother activities not permitted to be carried on by a "Corporation" exempt from Federal Income Tax Revenue Code of 1954 or by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954, as such provisions are presently in force and effect or as they may be amended from time-to-time.

ARTICLE IV

The corporation shall have members.

ARTICLE V

The address of the initial registered office of the corporation 37 Meadows Loop, Blaine County, P. O. Box 177, Ketchum, Idaho 83340, and the name of its initial registered agent at such address is Randall Acker.

ARTICLE VI

The number of directors of the corporation shall be four and may be increased or decreased as provided in its Bylaws.

ARTICLE VII
