AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence from the date hereof, with its registered office in this State located at Homedale in the County of Oxyhee, and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 29, Idaho Code, Annotated.

INCORPORATION

HOMEDALE CHURCH OF THE NAZARENE, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being the duly elected and installed officers of Homedale Church of the Nazarene of Homedale, Idaho, elected, qualified and installed, pursuant to the custom and discipline of such organization. do hereby certify that pursuant to a resolution duly adopted at a regular meeting of said church, held in Homedale, County of Owyhee, State of Idaho, on the 3rd day of December, 1950, after all of the members of said church had been given two weeks notice of said meeting to the effect that the question of the incorporation of said church would be considered at said meeting, as appears in the affidavit of publication hereto attached, and by this reference made a part hereof; and that all of the members present at such meeting, being and constituting a quorum of the membership of said church, pursuant to the custom thereof, voted in favor of said incorporation of said Homedale Church of the Nazarene, and under and by virtue of the laws of the State of Idaho, and in particular with the provisions of Chapter II, Title 29, Idaho Code Annotated 1932, and we, the undersigned officers, do hereby certify:

FIRST: That the name of this corporation shall be "Homedale Church of the Nazarene, Inc.."

SECOND: That said Church has been duly and properly instituted, pursuant to the custom and discipline of the Church of the Nazarene, and is a subordinate organization of the said Church of the Nazarene.

THIRD: That the purposes for which said corporation is formed are:

- ene in the City of Homedale, Wwyhee County, Idaho, and to provide a place for public worship of the same in the said City of Homedale, Idaho, and to establish, maintain and conduct shhools and religious instructions and to further in general religious and charitable work and to that end may adopt and establish by-laws and make all rules and regulations deemed necessary and expedient for the management of its affairs, in accordance with law and not inconsistent with these Articles of Incorporation, or with the Manual adopted by the General Assembly of the Church of the Nazarene in the United States, of which this corporation is a subordinate part.
- be sued, in its corporate name, and in such name to acquire or receive by purchase, gift, grant, devise or bequest, any property, real and personal or mixed, and the same to hold, sell, transfer, mortgage, convey, loan, let or otherwise use, in accordance with the law and the custom and discipline of said Church, but said corporation has no power to divert any gift, grant or bequest from the special purposes designated by the donor, and in general to do such other acts and things as may be authorized by law, and as may be considered useful and necessary for the carrying on of the purposes and objectives of said Church, as defined in its Manual hereinbefore referred to, as now exists or may be hereafter amended by the General Assembly of the Church of the Nazarene of the United States.
- (c) To purchase, or otherwise acquire, or hold, lease, sell, exchange, assign, transfer, mortgage or otherwise dispose of and to invest, trade and deal in and with real property and any and all interests therein, and with personal property of every class and description.
- (d) To borrow money, to issue bonds, debentures, notes and other obligations of this corporation from time to time, for Page 2.

FRANK KIBLER LAWYER NAMPA, IDAHO any of the objectives or purposes of this corporation, and to mortgage, pledge, hypothecate or convey in trust, any or all of its property, to secure the payment thereof.

- (e) That the Church of the Nazarene is composed of those persons who have voluntarily associated themselves together according to the doctrines and policy of said church, and who seek holy Christian fellowship, the conversion of sinners, the entire sanctification of believers, their upbuilding in holiness, and the simplicity and spiritual power manifest in the primitive New Testament Church, together with the preaching of the gospel to every creature.
- (f) That where not inconsistent with the statutes of the State of Idaho, it is the intent of the incorporation that the corporation shall be subject to the government of the Church of the Nazarene, as from time to time authorized and declared in its Manual by the General Assembly of said Church.
- (g) The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall be in no wise limited or restricted by reference to and inference from terms of any other clause, but shall be regarded as independent in purposes and powers and no recitation, expression, or declaration of specific or special powers or purposes herein enumbrated, shall be deemed to be exclusive but it is hereby expressly declared that all other lawful powers not inconsistent herewith, are hereby included.

FOURTH: The duration of this corporation shall be perpetual.

FIFTH: The location and Post Office address of the registered office of this corporation in the State of Idaho, shall be Homedale Church of the Nazarene, Homedale, County of Owyhee, State of Idaho, which said place shall be the principal office for the transaction of thebusiness of this corporation.

SIXTH: That it is the custom of the Church of the Nazarene, that the management of the real estate of such corporation shall be under the control of one Board, and that the promotion, operation and maintenance of such corporation shall be under the control of another Board, and that by reason thereof, the Board to control the real estate shall be known as the "Board of Trustees", and shall consist of four members of said corporation, and that the Board to manage the promotion, operation and maintenance of the corporation shall be known as the "Board of Stewards", consisting of seven members and other officers of the corporation, provided in the Manual of the Church of the Nazarene, as follows, to-wit: Pastor, Sunday School Superintendent, Young People's Society President, and Women's Foreign Missionary Society President: and that said two boards, as enumerated hereinabowe, together with the other officers specifically mentioned, shall be and constitute the officers and boards of this corporation.

SEVENTH: This corporation shall not be a stock company and shall issue no bonds or stock or stock certificates, and that this corporation is not organized for the purpose of pecuniary profit.

EIGHTH: Membership in this corporation shall be limited and confined to persons who have now or may hereafter affiliate with the Church of the Nazarene, and subscribe to its beliefs and doctrines, as contained in its Manual, in so far as the same do not conflict with any of the laws of the State of Idaho.

NINTH: Neither membership, nor the corporate or propety rights, incidental to membership in the corporation, shall be transferable, but all property rights of said corporation shall be vested in and held by said Homedale Church of the Nazarene, in accordance with the Church Manual as the same now exists, or may be hereafter amended or changed by the General Assembly of the Church of the Nazarene.

ELEVENTH: The corporation shall prepare and hereafter adopt an official corporate seal which shall, for all purposes, be the corporate seal of this corporation.
