ARTICLES OF INCORPORATION OF 93 AUG 19 AM 8 31 BUFFUM CONSTRUCTION CO., INC.

KNOW ALL MEN BY THESE PRESENTS: THAT WE, The undersigned, being each full age citizens of the United States of America, do hereby certify that we have associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, pertaining thereto, to wit: Idaho Code sections 30-1-3, 30-1-4, et seq, and hereby adopt the following ARTICLES OF INCORPORATION:

ARTICLE I

The name of this corporation shall be Buffum Construction Co., Inc.

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

The objectives and purposes of this corporation shall be and are as follows:

1. To acquire by purchase, lease or otherwise, lands and interests in lands and to own, hold, improve, develop and manage any real estate so acquired; and to erect or cause to be erected on any lands owned, held or occupied by the corporation any buildings or other structures with their appurtenances; and to manage, operate, lease, rebuild, enlarge, alter or improve buildings or structures now or herafter erectedon any lands so owned, held or occupied. To encumber or dispose of any lands or interests in lands, buildings or other structures at any time

owned or held by the corporation.

2. To aquire by purchase, lease, manufacture or otherwise any personal property deemed necessary or useful in the equipment, improvement, development or management of any property, real or personal, at any time owned or in anyway held by the corporation. To invest, trade, deal, encumber or dispose of any personal property deemed beneficial to the corporation.

3. To cunduct any lawful business in the State of Idaho or any state, territory, the District of Columbia, colony or protectorate of the United States of America and in any foreign country. To have one or more offices or places of business within or without the State of Idaho and to carry out any lawful business authorized in these Articles outside of the State of Idaho.

4. To issue, re-issue or purchase the shares of capital stock in the corporation, according to law. Stock owned by the corporation shall not be considered voting stock in any way.

5. To perform any act with the power and copacity possessed by a natural person and to so perform any acts necessary to accomplish any lawful purpose of the corporation.

6. To exercise any lawful power now or hereafter conferred upon general business corporations by the laws of the State of Idaho.

7. To engage in and conduct wholesale or retail business of any kind or nature. To provide any services for hire of any kind or nature.

ARTICLES OF INCORPORATION - 2

It is expressly provided that the above and foregoing enumeration of powers, purposes and objects of the corporation shall not be exclusive nor limit or restrict the general powers of the corporation as allowed by the laws of the State of Idaho.

ARTICLE IV

The location of the registered office of this corporation within the State of Idaho shall be 3600 Americana Terrace #7, Boise, Ada County, Idaho 83706. The registered agent for the corporation shall be Karl Buffum, whose address is the same as that of the registered corporate office listed immediately preceding.

ARTICLE V

The corporation shall be authorized to issue 10,000 shares of no-par common stock. All shares shall be without par value.

ARTICLE VI

There shall be only one class of stock, designated as common stock. The shares shall not be issued until payment in full therfor has been recieved and such stock shall be non-assessable stock. The shareholders shall have no liability for corporate obligations. Each share of stock shall have the voting rights as now or hereafter granted by the State of Idaho.

ARTICLE VII

The incorporator has determined and approved that he shall act as the initial board of directors of the corporation.

ARTICLES OF INCORPORATION - 3

Said incorporator is of full age and is a citizen of the United States of America.

ARTICLE VIII

The corporation shall be managed by a Board of Directors governed by the by-laws of the corporation. The Board of Directors shall consist of not less than one nor more than five members. The name and addresses of the initial Board of Directors are the same as the incorporator named above and he shall so serve until the first election of directors.
