KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned citizens and residents of the United States of America and State of Idaho, and of legal age, for the purpose of organizing a corporation pursuant to the laws of the State of Idaho, do hereby make, sign, acknowledge, certify and file this certificate and Articles of Incorporation for the purpose as follows:

ARTICLE IV.

PRINCIPAL PLACE OF BUSINESS

- Section 1. The location of the corporation's place of business in this state is Idaho Falls. The corporation may also maintain offices at such other place or places in the State of Idaho and the United States as the Board of Directors may from time to time decide.
- Section 2. The operation and business of this corporation shall be carried out in the City of Idaho Falls, County of Bonneville, State of Idaho, and in such other counties in the State of Idaho and in other states of the United States as the Board of Directors may from time to time decide.
- Section 3. The initial registered agent for the corporation shall be Raelene R. Barzee. The address of the registered office shall be 8685 North 5th West, Idaho Falls, Idaho 83401.

CAPITAL STOCK

- Section 1. This company is a stock company chartered under the laws of the State of Idaho.
