

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST

The name of the corporation is Ted's Diesel Electric Service, Inc.

SECOND

The period of its duration is perpetual.

THIRD

The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under Idaho Business Corporation Act.
