
CERTIFICATE OF MERGER OR CONSOLIDATION

ARTICLES AND PLAN OF MERGER

Merger of WOODMAN'S OFFICE SUPPLY, INC. (an Idaho Corporation) and KALBUS OFFICE PRODUCTS, INC. (an Idaho Corporation).

Merger will be effective on July 1, 1989. The surviving corporation will be KALBUS OFFICE PRODUCTS, INC., which will have no changes in the Articles of Incorporation, including the authorization to issue 500 shares of One Hundred and no/100 Dollars (\$100.00) per share par value common stock.

All shares of common stock of WOODMAN'S OFFICE SUPPLY, INC. will be canceled and no payment or exchange will be made. Stock outstanding consists of One Thousand Four Hundred Forty-One and One-Half (1,441-1/2) shares. In addition, there are Fifty-Seven (57) shares of Treasury Stock.

All assets and liabilities of WOODMAN'S OFFICE SUPPLY, INC., will be transferred to the succeeding corporation. Included are any credits, not now known, such as State Employment Reserve Account #0000942502 of the Department of Employment, State of Idaho.

All of the common stock issued and outstanding is owned by James W. Kalbus on July 1, 1989. No additional stock will be issued by this merger.
